- Department, its insurer, and their respective attorneys, in the defense of such action or proceeding, pay any damages or costs awarded against me.
- 9(D). That nothing in this Agreement confers or removes workers compensation coverage while performing the Volunteer Services. Whether workers compensation coverage exists is dependent solely on the provisions of *The Workers Compensation Act* and Regulations made under it.
- 10. That I will not incur any expenses or debts on behalf of, or make any commitments for, the Department without first obtaining written permission from an authorized employee of the Department.
- 11. That I will not assign or transfer this Agreement or any of my rights and obligations hereunder without first obtaining the Department's written permission.
- 12. That if I am required or find it necessary to operate my own motor vehicle while providing the Volunteer Services or if I operate any motor vehicle owned by or leased to the Department, I will at all times have in full force and effect a valid and current driver's license according to the laws of the Province of Manitoba. In the former case, I will obtain at my own cost and expense, appropriate motor vehicle insurance coverage.
- 13. The document and the attached Duty Description contain the entire agreement between the Department and myself. There are no undertakings, representations, or promises expressed or implied, other than those contained in this Agreement and that any amendments will need to be consented to in writing by myself and an authorized employee of the Department.
- 14. If I continue to provide the Volunteer Services past the Expiry Date, I agree that all of the terms and conditions of this Agreement (excepting the duration of the Volunteer Services as indicated in section 2 will automatically be in force and effect during the period and times in which I continue to provide the Volunteer Services.
